DANGER: Hot engine parts, please do not touch or lean on the engine area while entering and leaving the vehicle.

CLOTHES: Please wear tight-fitting clothes. Scarves, ties and belts should be secured. We are not liable for improper clothing as well as damaged clothing.

You are obliged to wear a bonnet under your rented helmet for hygienic reasons.

If you are not at the starting line for the indicated training round, your starting licence becomes void.

Anyone driving negligently or recklessly will be exempted from driving.

The racing circuit can be altered frequently. Thus we request you to drive slowly in the first rounds.

Herewith I declare and particularly recognize by my signature that I will use all premises, devices as well as the karts of the Nürburgring 1927 GmbH & Co. KG at my own risk. In particular, the Nürburgring 1927 GmbH & Co. KG is not liable for personal injury and damage to property incurred by me or by a third party by / on occasion of the operation of the rented karts, by / on occasion of the operation of other vehicles / vehicles used by third parties, and moreover for damages incurred by me due to the conduct of other drivers or incurred by a third party due to my own conduct.

The exclusion of liability applies to all my personal and private property, particularly to vehicles parked on the ground provided by the Nürburgring 1927 GmbH & Co. KG.

In particular, I exempt the Nürburgring 1927 GmbH & Co. KG of all liability claims for liability claims of other persons or visitors or any other third party which I am responsible for in connection with the use of the premises / karts and the access to the premises. In case of liability claims against my person, I will renounce any claim under a right of recourse against the Nürburgring 1927 GmbH & Co. KG.

The above mentioned exemptions of liability are not applying to such damages which are caused through gross negligence and wrongful intent on the part of the Nürburgring 1927 GmbH & Co. It is explicitly emphasized that persons with heart problems or high blood pressure are particularly endangered.

I assume liability for all damages on the kart used by me that are caused by myself or others due to accident, improper use or due to the non-observation of instructions by the Nürburgring 1927 GmbH & Co. KG or its staff and agents.
